# City of Ottawa 2024 Spring Tree Planting Program

## **Program Overview:**

The City of Ottawa is committed to enhancing its green spaces and promoting environmental sustainability through its cost-sharing tree planting program. This initiative seeks to encourage residents to participate in the beautification and preservation of their neighborhoods by planting trees in collaboration with the city.

### **Eligibility**

Residents within the City of Ottawa are eligible to participate in the program. Please be aware that participation in this program will be on a first-come, first-served basis until all trees are allocated.

## **Cost Sharing**

The City of Ottawa is offering a cost-share program for residents interested in having a two-inch tree planted in the parkway (berm) in front of their home. Participants will pay a flat rate of \$100 per tree. Each participant can apply for up to two tree per lot, depending on the availability of trees and space.

### **Tree Species**

Participants may request their preferred tree species from the list provided below. However, it is important to note that city staff will have the final say in selecting the trees. The selection process will take into account factors such as location, availability, neighborhood diversity, and overall tree variety across all plantings.

Listed below are the available trees species. All trees have a 2-inch caliper.

<b>Exclamation Planetree</b>	55'- 65'	40'- 50'

#### **Planting Guidelines**

Tree planting will be performed by a landscape contractor hired by the City of Ottawa.

While residents may suggest locations for the tree(s), these suggestions will be reviewed for suitability and to avoid utility conflicts.

Please indicate the desired planting location on the application and/or mark it in the field. A representative will conduct a field check of the location. If the tree poses a risk of interfering with utilities or is deemed too close to the driveway, the city will have the final say on its placement.

Locations will be assessed for suitability based on the following guidelines:

- Only small trees may be planted under overhead power lines.
- No tree may be planted within five lateral feet of any underground water line, sewer line, transmission line or any other utility.
- Ensure proper spacing between species:
  - o Small tree species must be planted at least 20 feet apart.
  - o Medium trees species must be planted at least 25 feet apart.
  - o Large tree species must be planted at least 30 feet apart.

#### **Watering of Trees**

All participants are required to take on the responsibility of watering the tree for a minimum of two years. It is essential to water the tree deeply at least once a week, particularly during dry periods. To ensure proper watering, allow a garden hose to run slowly at medium pressure for approximately five minutes on each side of the root ball.

#### **Application Process**

To participate in the tree planting program, please fill out the application form and include a \$100 payment.
