ORDINANCE NO. 018 -2024

AN ORDINANCE AUTHORIZING THE SALE OF MULITPLE ITEMS OF PERSONAL PROPERTY

(Multiple Vehicles and other Equipment)

WHEREAS, the City of Ottawa, Illinois, owns multiple vehicles and other equipment, which are no longer useful or necessary to the City, and

WHEREAS, it is in the best interests of the City of Ottawa that such items of personal property be sold pursuant to 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4) upon the terms and conditions hereinafter set forth.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OTTAWA, ILLINOIS, AS FOLLOWS:

Section One: That the following items of personal property be publicly sold in an "AS IS" condition to the highest bidder:

Madison Street, Ottawa, Illinois, and at such other locations as determined by the Commissioner of Public Property.

Section Four: That persons desiring to purchase any of said items of personal property will submit a sealed, written bid to City Hall, 301 W. Madison Street, Ottawa, Illinois before 4:30 p.m. on June 3, 2024.

Section Five: All bids will be deemed an offer to purchase and may not be withdrawn once submitted; the City may accept or reject any of the bids at the regular session of the City Council commencing at 7:00 p.m. on June 4, 2024. Any bid accepted by the Council will be deemed a contract between the City and the Bidder, and all successful bidders must pay to the City the full amount of their bid no later than June 11, 2024. No property may be removed until paid in full.

Section Six: The City of Ottawa express reserves the right to reject any and all bids and to waive any technicalities.
