## AVAILABLE FLOODPLAIN MAP INFORMATION SERVICES

Notice to: All property owners with land in the floodplain (special flood hazard area)

Subject: You have property located in a regulated special flood hazard area/floodplain....

- *Do you know the City's Floodplain Code requirements?*
- *Do you know the real hazards of flooding and floodplain areas?*
- *Is your property insured for the flood and sewer backups? Protect people and property.*
- *Does the property have a history of flooding/Is there cumulative damage from past floods?*

As a public service, the City of Ottawa's Community Development Department can help and provide you with the following information upon request:

1. Whether a property is located within a Special Flood Hazard Area (SFHA) as shown on the current Digital Flood Insurance Rate map (DFIRM) of LaSalle County.
2. Additional flood insurance data for a site, such as the FIRM Zone and the Base Flood Elevation (BFE) and depth of water, if shown on the FIRM or any other engineered study.
3. Literature and information on the mandatory flood insurance purchase requirements that can help people who are seeking a mortgage or loan for property located in the SFHA. Also visit <https://agents.floodsmart.gov>
4. Access to Elevation Certificates that have been processed in the City.
5. The City has two Certified Floodplain Manager's on staff that can assist with questions on stormwater management, floodway, and floodplain issues.
6. Copies of Map Amendments (LOMA) and Letters of Map Revisions (LOMR) that have occurred within the City.
7. A Flood Hazard Map and many other flood related resources can be found online at [www.cityofottawa.org](http://www.cityofottawa.org) (go to "Government" on opening page and seek "Flood Resources") or the City's newly designed webpage dedicated exclusively to floodplain management at [www.ottawafloods.org](http://www.ottawafloods.org).
8. Aerial images and photos of recent flooding can be viewed at City Hall, upon request. Information about historical flooding and your property may be available at the City Community Development Department.
9. New Flood Inundation Mapping Tool [https://www.weather.gov/lot/ottawa\\_inundation\\_maps2016](https://www.weather.gov/lot/ottawa_inundation_maps2016).
10. Professional engineers are available for drainage and storm water problems and potential solutions. They are available to visit a site on request. Check with the City engineer for other areas of known flooding outside of the floodplain.
11. The City now has one foot contour interval information for the entire city. Aerial images with this topographic information is available at City Hall. Flood depth information can be viewed on our inundation maps. You may request this information over the phone, via email or by stopping in at City hall.
12. Construction activities in the Special Flood Hazard Area requires permits. If the work is inside a floodway, permits from the Illinois Department of Natural Resources, IEPA, and the Army Corps of Engineers may also be required. Please check with the Community Development Department before doing any work in the flood hazard area.

If you have questions relating to any floodplain, stormwater, or flooding related issues please provide us the address/or other site- specific location information.
