Special meeting of the Council of the City of Ottawa, Illinois.

Present: Mayor Robert Hasty, Commissioners Thomas G. Ganiere, Marla K. Pearson and Brent F. Barron (via phone).
Absent: Wayne A. Eichelkraut Jr.

A public hearing was held regarding the Operating Budget for fiscal year 26. City treasurer, Don Harris explained that the budget was being passed with a \$1.2M deficit. This deficit will be paid with reserves. Commissioner Ganiere added that there are projects budgeted on each side of the budget, which may not get done. The Mayor added that we are waiting on federal money right now for grant reimbursements. Commissioner Barron asked if any changes were made. With no one from the public commenting, the public hearing was declared closed by the Mayor at 8:02 a.m.
