Once the board has the final candidate number after IO Solutions completes its vetting procedure, the board will go look at the Cafetorium to plan how the room should be set up for testing. Brianne has been in touch with Carrie Price at Central Intermediate to coordinate a tour of the room.

Fire Oral Interviews

The board discussed options for Firefighter oral interviews due to the large number of candidates. The current oral interview date is June 14, 2023. Depending on the percentage that pass the written exam, a second day of oral interviews might be needed. There was discussion about doing group interviews, possibly taking 4/5 candidates at a time. A final plan will be decided for oral interviews, once the board has final numbers from IOS and a final number of candidates that have passed the written exam.

New Business

The board will need to set Sergeant testing dates to LETA for promotional testing. The board reviewed the Testing and Assessment Services Agreement, Steve Malinsky moved to recommend the LETA agreement to Council for approval, second by Ken brown. All ayes. Recommendation passed.

Testing will most likely take place in November as the list will be exhausted due to an upcoming retirement. This company may also be used for future promotional testing depending on how everything goes with this round of promotional testing.
