### **NEW BUSINESS**

b. Public Hearing – David Brewer request initial zoning to R (Rural) District and A-2 (single and two family) District to R (Rural) District at 1800 Poplar Street legally described as the south twelve (12) acres of the east half of the northeast quarter of the southeast quarter of section three, township 33 north, range 3 east of the third principal meridian except the north 30 feet thereof and also except the south 550 feet thereof, in LaSalle County, Illinois.

Davis Brewer stated he would like to rezone the property to R-Rural. The property had a nice house and shed. When he purchased the property the house and shed were gone, and he has cleaned it all up. Currently he stores his camper and boat outside. He would like to build a shed and possibly a house in the future. Debbie Burns asked about access. He accesses the property from the west end of Catlin Street in an easement. No public comment.

c. Public Hearing – Ottawa River Rescue Squad requests a conditional use for a Civic Use at 701 Hitt Street, legally described as: That part of Lots 1,2,3 and 4 in Block 33 of the Original Town, now City of Ottawa which lies South Of Illinois Route 7 l and East of the Illinois Railnet Railroad described as follows: Beginning at the Southwest comer of the Southeast Quarter of Section 11, Township 33 North, Range 3 East of the Third Principal Meridian; thence North 89 degrees 58 minutes 37 seconds West 81.41 feet on the South Line of the said Section 11, also being the South line of said Block 33, to the Easterly right-of-way line of the Burlington-Northern Railroad thence, Northerly 108.92 feet on said Easterly right-ofway line on a curve to the left with a radius of 1,482.10 feet and a chord bearing North 19 degrees 41 minutes 39 seconds East 108.89 feet to the Southerly right-of-way line of Illinois Route 71; thence, North 61 degrees 31 minutes 40 seconds East 319.20 feet on said Southerly right-of-way line to the East line of Block 33; thence, South 0 degrees, 05 minutes 47 seconds West 254.61 feet said East line to the Southeast corner of said Block 33; thence, North 89 degrees 58 minutes 37 seconds. West 235.46 feet on the South line of said Block 33 to the Point of Beginning, and all being situated in the City of Ottawa; La Salle County, Illinois. PIN: 22-11-421-005

Brian Brenbarger, president of Ottawa River Rescue Squad - plan to relocate and put up a new building to hold their equipment, conference rooms with possibly a second floor. Environmental work has been done, they can't dig down. Slab on grade. Talking with the architect and may need an oil separator. Debbie Reagan question renting out space, maybe limited on parking. Brian stated they are unsure on specific uses will depend on space. Working out the details with the architect and engineers. No security fence is planned. Plan to launch at Allen Park.
