Moved by Jean Eltrevoog, second by Rob Schmitt that based on the recommendation for the City's Corporation Counsel, the following amendment be made to the Civil Service Commission Rules and Regulations (changes are delineated by strikethroughs and underlines):

<u>RULE VII</u> ELIGIBLE REGISTERS

7.1 <u>Eligible Registers – Promotional and Original Entry</u> – Names of persons who have passed the examination will be placed on eligibility lists for such class in order of relative grades received without reference to priority time of examination. Ties in the final scores shall be resolved by arranging names of such eligibles according to their ratings on that part of the examination which has greater weight; and if still not resolved, by order of application for examination has the greatest weight; and if still not resolved, then as according to their ratings on the part of the examination which has the second greatest weight; and if still not resolved, then as according to their ratings on the part of the examination which has the third greatest weight. If such eligibles have tied and have received the same ratings on all parts of the examination, then names of persons will be arranged by order of application for examination. The name of no person shall be entered on an eligible register resulting from an examination whose general average shall be less than 70 percent of complete proficiency in the subjects of examination taken as a whole. This register shall be posted within 60 days.
